We hope you have had the opportunity to enjoy the newly repaired walking path during the beautiful weather recently. In September the path was slurry sealed and patched by Wilson Asphalt & Sealing. (A slurry seal is the application of a mixture of water, asphalt emulsion, aggregate - very small crushed rock - and additives to an existing asphalt pavement surface.) In addition, Wilson Asphalt & Sealing prepared and seeded the lake drainage area. There is still some detail work to complete in that area but progress is being made to improve drainage. - Mike Smith presented the 2021 draft budget. After review and discussion, 2021 dues will remain the same. The path is twenty years old and showing its age. Resurfacing is expected to be needed within the next five to ten years at an estimated cost of \$50,000.
