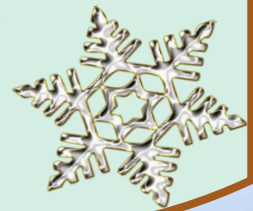
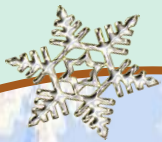
Notes from the November Meeting:

- The park drainage improvement project made major headway as dry conditions arrived. Excavation was completed to the primary inflow stream, and buried tiles were exposed and cleaned. Next steps include prepping the ground for grass seed, and clearing above the path near lots 8 and 9.
- The 2020 draft budget was reviewed. Initial projections are that dues will remain the same. Path maintenance estimates are still pending however.
