Hello Heather Lake. You may remember that shortly after the Annual Meeting last March the first Newsletter from your new Board mentioned a revised Design Review Manual. We understand that any revisions to the Design Review Manual can be a sensitive subject and has had reactions in the past. Since that meeting the Heather Lake Association Board has discussed the DRM at length, and has reviewed a number of resources, working to make sure that the DRM is fair, consistent and clear.

The new DRM being drafted is not about any new restrictions, It is being drafted with an emphasis on closing loopholes and clarifying language so that any Board of Directors, present or future, treats all homeowners the same. As your Board Vice President the initial draft has been a process of: initial draft > review by the entire Board > feedback from the Board > then re-draft. Now, we want your input to place the finishing touches. We hope to see you at the open meeting.

Treasurer Announcement

Invoices for the 2nd half of 2023 will be included with the December Newsletter. We are currently researching alternative methods of payment for HOA assessments. Effective July 2022 PayPal implemented a policy change that does not allow for the Heather Lake Association business account to receive payments through the "Friends and Family" payment option. PayPal now charges a 2.99% fee on the amount of the payment received. Year-to-date we have paid approximately \$182 in PayPal fees and would expect that to double if we do nothing. Passing the PayPal fee to the owners using that method of payment is one consideration as we continue to research alternative payment options. Payment by check or using your financial institutions' bill pay option are the best choices at this time. - *Ann Deskins*

Park and Common Grounds

The front entrance to the neighborhood was cleared of weeds and growth in July thanks to the Dove, Hamilton, Buckland, Pekar, Shaffer, and Mitchell families. It was fun meeting neighbors and coming together as a community. The missing Alspach/East Glenhurst street sign was replaced in August by Bloom Township.

A lot of progress has been made around the pond this year; such as maintaining the weeds on and off the path, cutting tree branches, and clearing out ditches. Elliott's Mowing added gravel, topsoil and seed to the muskrat runs to help make the area safer and inhibit erosion. New signs were posted at the entrances of the pond stating our 'Catch and Release' policy, and an additional fishing access was cleared at the northeast end.

Looking to 2024, our current mowing company has quoted an increase in their weekly prices. We will collect additional quotes and will hopefully find a less costly vendor. Muck Digester was suggested by The Lake Doctors to help eliminate some of the sediment deposit on the southwest end of the pond. A more affordable option was purchased and implemented.
