### Updated Design Review Manual Now Available

After many months of work, consulting with our Association's attorneys, and reviewing feedback from Heather Lake homeowners, we are pleased to tell you that the revised Design Review Manual (DRM) has been approved and is now available on the Heather Lake Association website (www.heatherlake.org).

The Board has attempted through this revision to maintain the core of past DRMs while also consolidating, modernizing, and clarifying language that may have previously been confusing. Over twenty modifications made were based upon homeowner input after the first draft was released. Our law firm assisted us to clarify gray areas, remove and add language, and let us know what simply isn't enforceable.

Thank you to everyone who provided input, either at the open meeting, via email, or by personal chat. It is our hope that the new DRM is more objective and less ambiguous.

We are trying to keep cost down by offering the DRM on the website; however, if you are unable to access the DRM via the website, please contact one of the Board members and we will get a hard copy out to you.

### CY2024 Annual Budget

Accompanying this newsletter is the CY2024 Budget as approved by your Association's Board. Preparation of the annual budget is one of the primary duties of the Board, as it determines the amount of money each of us contributes toward maintaining, protecting, and enhancing our properties.

After carefully reviewing our financial position, contract bids, and estimated expenses, the Board has determined that the total fees will be increased 4.44% for calendar year 2024, from \$450 to \$470.

The Operating Assessment makes up \$410 of the 2024 fees, while the Reserve Assessment makes up the remaining \$60.

While we tried to keep assessments flat for 2024, the fact that mowing expenses will increase 44% made that an impossible task. The mowing expense (approximately \$21,000) represents approximately 71% of the 2024 Budget.

## Common Grounds Update

Thank you for making 2023 a successful year for the park and common grounds area. With the help of the community and select vendors, we were able to maintain the balance of a natural and well manicured area. A few accomplishments were new river birch trees, additional grass carp, new signage, cleaned front entrance areas, and repaired muskrat damage.

Looking forward to 2024, we will be moving our Lake Doctors algae treatment in March to May. This will allow two treatments in May when the weather is warming up and creating that algae growth. Mowing quotes from six vendors were obtained and even though Elliott's Mowing increased, they still were the best priced and had the lowest risk.

Hopeful goals for this year are to maintain the previous overgrown areas, replace the entrance sign, repair the fence at the W. Glenhurst pond entrance, maintain cattails to ensure they do not creep out into the pond, and investigate drainage issues on the southwest side of the pond.
