HEATHER LAKE BOARD

The Heather Lake Association Board members are volunteers. They are not paid a salary or a fee, and they do not get any special perks. They use their personal time and resources to serve our community.

Following the hailstorm on May 3, 2022, the Board also experienced the same frustrations as you in dealing with repairs and damage to our homes. The insurance inspections, the scheduling of vendors and the never-ending delay of products and shortage of materials continue for all of us.

However, we considered the welfare of our community and our obligation to our volunteer duties. The Board moved quickly to help our neighbors identify the proper procedure to seek approval and get started on the repairs to their homes. The Board:

- * immediately mailed a notice and a Design Review Application (DRA) to homeowners clarifying the proper procedure and currently approved color palate.
- * worked quickly to approve submitted DRA's.
- * answered emails and phone calls seeking additional clarification and guidance.
- * approved partial DRA's so homeowners could quickly take advantage of available resources.
- * identified bottlenecks in the approval process and implemented revised procedures.
- * worked outside their assigned position duties to keep the process moving smoothly.
- * created an information-only email address for quicker responses and DRA decisions.

In addition to these added catastrophic storm-related duties, the Board kept the Heather Lake Association in compliance by performing their assigned ongoing duties.

ANNUAL MEETING REMINDER

HEATHER LAKE ASSESSMENTS

Here are a few of the services and expenses that make up your association assessments.

- copying, postage, Paypal fees
- electric for the pond aeration system
- insurance
- legal/attorney retainer and legal action expense
- property tax
- lake maintenance, water testing/inspection/treatment, algae control and muskrat removal
- common grounds landscaping, mowing, weed control, tree removal, trimming, and replacement; signage and walking path maintenance and replacement

ARCHITECTURAL REVIEW

The storm last spring resulted in a record number of Design Review Applications (DRA's). The Architectural Review Board (ARB) worked diligently to review and provide recommendations to the Board. Since March 2022, 34 applications have been sent to the Board for determination. The ARB is functioning at a diminished capacity and would welcome and encourage you to join. Your help is needed.

The May 3rd hailstorm and the resulting damage underscored the confusion and various problems with the current Design Review Manual (DRM). About a year and a half before the storm, the Board began discussing the ambiguity and the potential legal challenges to the changes made in 2017 to the DRM. The work the Board is doing intends to modernize it and bring it back in line with the 1999 Heather Lake Subdivision Summary of Covenants and Restrictions, where vinyl siding was permitted on a limited basis and used to determine the majority of the homes built since then.

COMMON GROUNDS OVERSIGHT

The Common Grounds Oversight Committee (CGOC) had a busy year. The committee focused its attention around the lake and the West Glenhurst entrance feature. Unsightly trees were removed and others were trimmed. Overgrown areas were cleared of bushes and vines. Muskrat remediation was employed and will continue until all are gone.

Hail damaged the Heather Lake sign and fencing in the West Glenhurst entrance feature, along with some signposts near the lake. These will be replaced/repaired in the spring along with new plantings. There will be five River Birch trees planted on the NW side of the path, replacing the white pines removed last summer. The CGOC welcomes and encourages member volunteers.
